Modification of the COVID-19 Operating Plan for the Harris County Justice Courts to Allow for the Resumption of In-Person Proceedings

Dear Judge Schaffer,

In accordance with the Supreme Court of Texas' Thirty-Sixth Emergency Order, which allows the Justice Courts to conduct in-person proceedings if the Local Administrative Judge adopts minimum standard health protocols for court proceedings that will be employed in all courtrooms and throughout all public areas of the court buildings and an in-person proceeding schedule, we submit to you for your approval this modification of the COVID-19 Operating Plan for the Harris County Justice Courts.

- 1. The Harris County Justice Courts will continue to use reasonable efforts to conduct dockets remotely and will allow or require anyone involved in any hearing or other proceeding of any kind to participate remotely, such as by teleconferencing, videoconferencing, or other means, where practical and as appropriate.
- 2. Not all courts will begin holding in-person hearings or other proceedings immediately. The decision of when to begin is up to each individual court and judge. Individual participants should check with their specific court to determine if in-person hearings are being held. In the event a hearing or other proceeding is scheduled for an in-person setting, upon request and good cause shown by a participant, the court will permit the participant to appear and participate remotely.
- 3. Each court will ensure compliance with the minimum standard health protocols adopted under the Modification of the COVID-19 Operating Plan for the Harris County Judiciary District Courts, County Courts at Law and Probate Courts to Allow for the Resumption of In-Person Proceedings (ATTACHED) and with the capacity/occupancy limits set forth by the Harris County Fire Marshal.
- 4. Courts will continue to require every participant in any proceeding to alert the court if the participant has, or knows of another participant who has (i) COVID-19 or a symptom of COVID-19, to include fever, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, sore throat, loss of taste or smell, congestion or

runny nose, nausea or vomiting, or diarrhea; or (ii) recently been in close contact with a person who is confirmed to have COVID-19 or is exhibiting the symptoms described herein.

- 5. Prior to a Justice Court scheduling a jury proceeding for an in-person setting, the court will seek approval from the Local Administrative Judge and comply with the provisions applicable to jury proceedings contained in the Supreme Court's Thirty-Sixth Emergency Order.
- 6. Finally, the reduce the threat of contracting or passing the COVID-19 virus, the courts continue to encourage all litigants and/or defendants to file civil filings and certain criminal filings through EFILETEXAS.gov, or utilize such other means as each individual court may permit, and dispose of any criminal matters as appropriate via the Justice Courts' website at www.jp.hctx.net.

Based on this submission, we as the Harris County Justice Courts, will resume any in-person hearings on March 22, 2021 unless we hear from you that this plan has not been approved. Thank you for your guidance in adopting the minimum health standards, and please let us know if we can be of any further assistance.

Modification of the COVID-19 Operating Plan for the Harris County Judiciary District Courts, County Courts at Law & Probate Courts To Allow for the Resumption of In-Person Proceedings

Dated: March 15, 2021

Under the current Thirty-Sixth Emergency Order Regarding the COVID-19 State of Disaster (Misc. Docket No, 21-9026), in-person proceedings may resume upon the Local Administrative Judge's creation of a plan for the resumption of such proceedings.

I have attempted to confer with the judges of the courts with courtrooms in county and I have determined that the following minimum standard health protocols for court proceedings and the public attending court proceedings that will be employed in all courtrooms and throughout all public areas of the court buildings will be used in the setting of in-person proceedings:

General

- 1. All judges will continue to comply with the Emergency Orders issued by the Supreme Court of Texas and Court of Criminal Appeals.
- 2. All judges and court staff will continue to comply with the masking, social distancing and safety protocols set out in the COVID-19 Operating Plan for the Harris County District Courts, County Courts at Law & Probate Courts.
- 3. All judges will continue to use reasonable efforts to conduct proceedings remotely, and to accommodate litigants, lawyers, witnesses and other participants who request to appear remotely.
- 4. All judges and court staff will continue to comply with public health, county official and Supreme Court mandates concerning masking, social distancing, and health and safety protocols.

5. The local administrative district judge will continue to maintain regular communication with the local health authority to consider adjustments to this operating plan as necessary in light of conditions in Harris County.

Judge and Court Staff Health

- 1. Judges and court staff who can perform the essential functions of their job remotely will continue to consider teleworking.
- 2. Judges or court staff who feel feverish or have measured temperatures equal to or greater than 99.6°F, or with new or worsening signs or symptoms of COVID-19 such as cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, or having known close contact with a person who is confirmed to have COVID-19 will not be permitted to enter the building and should seek medical advice.
- 3. Unless exempted by a Judge in that Judge's courtroom, judges and court staff will continue to wear face coverings while in the courthouse.
- 4. Judges and court staff will continue to practice social distancing, and practice appropriate hygiene recommendations.
- 5. Protective Measures: The sneeze guards installed by the County will remain in place. The County will continue to strive to provide each court with face coverings and gloves for staff and participants who show for in-person matters. The County will, throughout the day, clean "touch points" and will, as able, perform a thorough cleaning of the complex at least once a week.

Scheduling

Each court will strive to reduce its number of in person hearings and will strive to schedule in person hearings in such a way as to maintain proper social distancing within the courtroom itself. As Harris County is a large county with specialized divisions, each division will establish a schedule to stagger dockets to reduce the flow of litigants, witnesses and general public entering the courthouse complex at one time. Each division will have its plan posted on the County website for district, county, probate or justice of the peace courts. Plans already received are attached as Exhibits A-D.

Social Distancing

- 1. All persons not from the same household who are permitted in the court building will be required to maintain adequate social distancing.
- 2. Elevators, restrooms, courtrooms and hallways will continue to be periodically reviewed for compliance with the most recent social distancing recommendations.

Gallery

- 3. The maximum number of persons permitted in the gallery of each courtroom has been determined and posted. The maximum capacity of the courtroom will be monitored and enforced by court staff.
- 4. The gallery of the courtroom has been marked to identify appropriate social distancing in the seating. Seating is limited to every other row.

Well

5. In each courtroom the counsel tables, witness stand, judge's bench, clerk, court reporter, and bailiff seating have been arranged in such a way so that there is appropriate social distancing.

Hygiene

- 1. Hand sanitizer dispensers have been placed at the entrances to the building, outside of elevators on each floor, outside of each courtroom, and outside of bathrooms.
- 2. Tissues have been placed near the door of the courtroom, at counsel tables, at the witness stand, on the judges' benches, and in the hallways.
- 3. The Department of State Health Service's "Stop the Spread of Germs Flyer" has been posted in multiple locations on each floor of the court building.

Screening

Screening will continue to ensure that no court participants have tested positive for COVID-19 within the previous 10 days, have had symptoms of COVID-19 within the previous 10 days, or have had recent known exposure to COVID-19 within the previous 14 days.

Face Coverings

- 1. Masks will be required to enter the courthouse buildings or any courtroom therein.
- 2. Courts will have the right to turn away an individual who declines to wear a mask.
- 3. Individuals will be encouraged to bring cloth face coverings with them, but if the individual does not have a cloth face covering, a disposable face mask will be provided, as long as supplies last.
- 4. Each court may choose to allow individuals to remove their mask in the courtroom, but masks must still be worn in the general court facilities (clerk's offices, restrooms, hallways, elevators and the like).

What does the bar need to know about the family law division?

The decision of when to begin is up to each individual court. <u>Please check with your specific court</u> to determine if in-person hearings are being held.
- 3) Prior to the scheduling of an in-person proceeding, attorneys and pro se parties must provide the court coordinator the number of individuals, including support staff, they desire to bring in-person. The court will review the request and coordinate with the other courts on the same floor. In addition, courts may request information concerning exposure to or symptoms of COVID-19, as required under the Thirty-Sixth Emergency Order Regarding the COVID-19 State of Disaster.
- 4) Each court will ensure compliance with the capacity limits set by the fire marshal and the COVID-19 Operating Plan for the Harris County District Courts, County Courts at Law & Probate Courts, implemented May 21, 2020. All courts will continue to comply with the social distancing and safety protocols set out in the COVID-19 Operating Plan for the Harris County District Courts, County Courts at Law & Probate Courts.

- 4) Each court will ensure compliance with the capacity limits set by the fire marshal and the COVID-19 Operating Plan for the Harris County District Courts, County Courts at Law & Probate Courts. All courts will continue to comply with the social distancing and safety protocols set out in the COVID-19 Operating Plan for the Harris County District Courts, County Courts at Law & Probate Courts. Face coverings will continue to be strictly required until further notice.
- 5) If the in-person proceeding is a jury trial, the court shall comply with the Jury Proceeding Addendum to COVID-19 Operating Plan for the Harris County Judiciary.
